





Kidde Fire Extinguisher Recall

Kidde has recalled more than 40 million fire extinguishers because they can become clogged or fail to discharge when needed. The recall includes 134 models manufactured between 1973 and 2017. All of those recalled have either plastic handles and or a push button pressure check on top. These units will be replaced free of charge and shipped directly to your home or business via FedEx upon request. The boxes and packaging that your new unit arrives in will be used to repack the recalled unit and a return label is also included.

Once you repack the defective unit you then call FedEx and they will pick up the old one. Be sure to check all of your extinguishers in your boat, car, home, garage, shop etc. I had seven and four were recalled and have been replaced within two weeks of notifying Kidde.

The easiest way to check if your units are involved in the recall is simply to call Kidde at 855-271-0773 while having your units close at hand and they will walk you through the verification process. If you wish to do the self service verification method you can go to their disjointed website (kidde.com) and after wading through several confusing pages and links you will eventually stumble upon a form to fill out requesting a replacement unit!!!

I have included some scanned images below to help you through the replacement process.

RE: Instructions for Return Shipment of Current Fire Extinguisher

Dear Valuable Customer,

Enclosed, please find your replacement fire extinguisher. The pre-paid shipping label which you will use to return your existing fire extinguisher is also located in this box. Please use the box containing your new fire extinguisher to return your current extinguisher.

Use the following steps to complete the return of your current fire extinguisher:

Step 1: Please read these instructions before proceeding.

Step 2: Carefully remove the new extinguisher from the outer shipping carton and from the inner box that it was shipped in. Both of these cartons will be used to return the affected unit.




Figure 1: Plastic Handle Design




Figure 2: Push Button Pindicator Design

Step 3: Ensure that the pull pin is securely positioned in your affected extinguisher - see figures 1 and 2 below:

Step 4: Place your affected fire extinguisher in the inner box and then place it into the outer shipping carton(s) (utilizing the same packing peanuts) and tape it closed with packing tape.

NOTE: When packaging your extinguisher, please do not remove or cover the black and white diamond on the over pack box. This label must be visible to FedEx or they will refuse pick-up.



Step 5: Cover the original label on the box with the new return label, ensuring that none of the original label is visible. Step 6: Contact FedEx Customer Service at 1-800-238-5355 and request to speak to an agent. Tell the agent the following:

- 1. The pickup request is for a Ground return with a return label
- 2. Provide the tracking number of the return label
- 3. Confirm the pickup address with the agent
- Advise that due to the contents being pressurized, the shipment is hazardous material and the required markings are already on the packaging that will be used for the return shipment (the black and white diamond).

The information above is required in order to pick up the shipment.

Note: The return package <u>cannot</u> be dropped off at a FedEx location and <u>cannot</u> be put into a FedEx Drop Box. A pickup must be arranged though the above process.

Plastic Handle/Bush-Button Pindicator Fire Extinguisher Recall

Q: Why is Kidde recalling products?

A: We are recalling certain Kidde fire extinguishers due to a potential safety issue. As consumer safety is our priority, we are working with the U.S. Consumer Product Safety Commission (CPSC) and other relevant authorities to notify customers with instructions for returning the affected models and how to replace them with different, unaffected models.

Q: How can I find out if my fire extinguisher is included in the recall?

A: Please contact us at (855) 271-0773 between 8:30 a.m. and 5 p.m. EST Monday-Friday (excluding holidays), or between 9 a.m. and 3 p.m. during the weekend to determine whether your extinguishers are affected. Alternatively, detailed information about which products are included is available below.

Q: How do I get a replacement?

A: Please contact us at (855) 271-0773 between 8:30 a.m. and 5 p.m. EST Monday-Friday (excluding holidays), or between 9 a.m. and 3 p.m. during the weekend to determine whether your extinguishers are affected.

If it is determined that you do have an affected fire extinguisher, a replacement will be shipped within approximately 10 to 15 business days from this call. Please keep your affected unit until the replacement arrives.

Please note, if your model is used with a personal watercraft, Kidde does not currently have an exact replacement for it, but is prepared to offer you a replacement extinguisher which is both US Coast Guard rated, and is similar in size. While it may not fit in the same location as the extinguisher that you currently have, there may be another space on your watercraft in which you can store this extinguisher.

Q: Do I need a receipt? How do I demonstrate my eligibility for a replacement?

A: No proof of purchase is required. Please supply the model number, year of manufacture, the unit's date code and serial number. Additional information may also be requested. You can find the model number and serial number on the unit's label.

Q: If I have an affected unit, what should I do with it?

A: Please retain your existing extinguisher(s) until your replacement(s) has been received. Upon receipt of your new fire extinguisher(s) you will find instructions for returning the recalled vunit(s).

Q: Which fire extinguishers are being recalled?

A: This recall involves two styles of Kidde fire extinguishers: certain plastic handle fire extinguishers and push-button Pindicator fire extinguishers.

<u>Plastic handle fire extinguishers</u>: The recall involves 134 models of Kidde fire extinguishers manufactured between January 1, 1973 and August 15, 2017, including some models that were previously recalled in <u>March 2009</u> and in <u>February 2015</u>. The extinguishers were sold in red, white and silver, and are either ABC- or BC-rated. The model number is printed on the fire extinguisher label. For units produced in 2007 and beyond, the date of manufacture is a 10-digit date code printed on the side of the cylinder, near the bottom. Digits five through nine represent the day and year of manufacture in DDDYY format. Date codes for recalled models

Thursday, June 14 How to Use a Chart


